Achievements 2005

- Revenues grew by 12.2% (including 9.3% organic growth).
- Most outsourcing contracts were renewed and new ones were signed against stiff competition resulting in an overall levelling-off in operating margin to 8%, although this figure is still at the upper end of the range in this business.

Outlook for 2006

Driven by an organic growth momentum and a buoyant albeit very competitive market, NEURONES will continue to seek external growth opportunities for value creation, in line with its industrial development policy, thereby sustainably increasing its earnings per share. As usual, the announcement on April 27th of revenues for the first quarter of 2006 will provide an opportunity to issue the forecasts for 2006.

Since its creation in 1985, NEURONES, an IT services company employing 1,500 people, has developed a global offer for IT infrastructures: integrating systems and networks (21% of 2005 revenues), outsourcing of distributed environments (60%) and application layers (19%) of information services. Recurring business accounts for over 60 % of total group revenues. NEURONES can boast 35 companies listed in the CAC 40 share index.
