Achievements

The trend in revenues reflects the highly successful line of services offered by the group in a dynamic market in volume terms. The 8.3% rate of organic growth over the 2nd quarter of 2006 (9.7% over the half) even exceeded that of the 1st quarter, if the calendar is taken into account. Between 1st January and 30th June, NEURONES recorded a sharp increase in employees (up 21%), from 1,456 to 1,766 people (167 of whom joined as a result of the consolidation on 1st June of an acquisition, which represented an increase in revenues of between 9 and 10 million euros over 12 months).

As a result of this increase in employees, the start-up of contracts relating to this acquisition and an unrelenting downward pressure on prices, the unaudited operating margin remained stable at around 5.7% over the second quarter.

Outlook

For 2006, NEURONES anticipates between 125 and 130 million euros of revenues, i.e. 15% growth in volume terms and an IFRS operating margin ranging from 6.5% to 7%.

About NEURONES

Since its creation in 1985, NEURONES, an IT services company employing more than 1,750 people, has developed a comprehensive line of services for IT infrastructures: integrating systems and networks (21% of 2005 revenues), outsourcing of distributed environments (60%) and application layers (19%) of information services. Recurring business accounts for 60% of total group revenues, which amounted to €108.9 million in 2005, for a net profit (Group share) of €5.9 million (IFRS).
