1st half 2006: sustained growth (+14%) and lower operating profit

Over the half-year, revenues were up 14% (9.6% generated internally). The strong internal increase in employees (net +132 people), earlier than expected, in the half-year, affected operating profit, which amounted to 5.5% of revenues. The continued growth in volumes combined with the traditionally more favourable seasonal effects, should result in a higher operating margin in the second half-year.

Outlook

For the entire FY 2006, NEURONES maintains its latest revenue forecast of 125 to 130 million euros and an operating margin between 6.5% and 7%.

Since its creation in 1985, NEURONES, an IT services company employing 1,750 people, has developed a comprehensive line of services for IT infrastructures: integrating systems and networks (21% of 2005 revenues), outsourcing of distributed environments (60%) and application layers (19%) of information services. Recurring business accounts for more than 60% of total Group revenues. NEURONES' customer base includes 35 CAC40 companies.
