1st half 2007: Strong increase in operating profit (+ 64%)

Over the first six months, revenues rose by 22 % (of which 16% is organic growth).

First-half operating profit, which was better than expected, posted strong growth mainly due to volume increases. It reached 7.4% of revenues (after inclusion of expenses related to stock options and free shares – 0.4%).

Outlook

Since the beginning of the year, NEURONES has signed 10 multi-year outsourcing contracts, i.e. yearly fees amounting to €9.5 million.

For 2007, NEURONES confirms its revenue forecast at €150 million. Buoyed by the profit posted for the first half and the highly satisfying level of business activity as observed during the third quarter, the group now aims to achieve an operating margin of at least 8% of revenues for the whole year (as against a previously announced range of 7% to 8%).

Following 19% growth in 2006, 2007 revenues are expected to increase sharply once again to total €150 million.
