#### 2007 achievements

NEURONES posted a strong performance in 2007. Operating profit recorded a 54% increase, reaching 8.9% of revenues (9.3% before inclusion of expenses related to free shares, stock options and impairment of assets). This rise is due to the combined effect of improved management factors and buoyant results in terms of volumes, backed up by steady demand (revenues grew by 20%, of which 16% in organic growth).

With €12.8m of free cash flow over the period, net cash flow reached €56.7m at the end of the financial year.

#### 2008 outlook

NEURONES will announce its 2008 forecasts when the 1<sup>st</sup> quarter revenues are published. Bolstered by the growth rates recorded over the last quarter of 2007, in particular, NEURONES is now well positioned to pass the €170m mark in yearly revenues.
