### Achievements

Business activity during the 2<sup>nd</sup> quarter of 2008 was particularly buoyant, with +19.2% in organic growth.

Bolstered by the high activity level during the 1<sup>st</sup> half, operating margin (not audited) increased by approximately one point compared to the 1<sup>st</sup> half 2007. It reached more than 8% of revenues (after inclusion of expenses related to stock options and free shares – 0.6%), i.e. an operating profit rocketing by almost 30% as against 1<sup>st</sup> half 2007.

### Outlook

Making allowance for the 2<sup>nd</sup> half economic forecasts, NEURONES confirms its expected revenues (at around €179 million) and operating margin (between 8% and 9%) for 2008.
