2009 annual revenues increase 14.3% to €216.4 million

Achievements

NEURONES' 2009 annual revenues (€216.4 million) are better than forecast, following unexpectedly buoyant activities in December.

Despite the difficult economic climate, the Group's organic growth remained positive throughout the four quarters. Against the backdrop of a downwards spiraling Consulting and IT Services market, the Group posted +3.4% organic growth over the year and +1.1% over the last quarter (to be compared to last year's outstanding performance, resulting in an unfavorable base effect).

2009 operating margin (audited) is higher than the last forecast and totaled 8.8% of revenues (after inclusion of expenses related to free shares, stock options and impairment of assets - 0.5%).

The Group's staff totaled 2,665 on 31 December 2009.

The final annual results will be published on Wednesday 10 March after closing of the Stock Exchange.

Outlook

As usual, forecasts for the year to come will be published along with the Group's 2010 1st quarter revenues.
