Achievements in 2009

With revenues rising 14.3%, of which 3.4% organic growth (to be compared to -3%/-5% in the market) and an operating profit which is up 3.8% on the 2008 record year, NEURONES got through 2009 by preserving its core features in financial and business terms.

The business operating profit reached 9.3% of revenues (8.8% after inclusion of expenses related to free shares, stock options and impairment of assets).

The 2009 net profit remained more or less the same as that recorded in 2008.

The net cash and cash equivalents at year-end stood at €59.6 million (or €2.54 per share).

Outlook for 2010

As usual, forecasts for the year to come will be published along with the Group's 1st quarter revenues. Despite uncertainties regarding the economic climate, the group:

- already anticipates higher organic growth in 2010, compared to 2009,
- and furthers its strategy in joining forces with companies boasting similar business profiles, in order to appropriately channel the significant cash flow available.
