#### Achievements

NEURONES' 1<sup>st</sup> half 2011 revenues increased by 21.1% in terms of organic growth, exceeding that recorded throughout 2010 (10.3%).

At the end of June 2011, operating profit\* (not audited) increased by 42%, standing at 9.0% of revenues.

#### Outlook

With constant structures, overall, for 2011, NEURONES raises its previous revenues forecast to €275 million and maintains its operating profit\* forecast of between 8.5% and 9.5% of revenues.
